Statement of Adoption for the Cambridgeshire & Peterborough Minerals and Waste Core Strategy and Proposals Map C Mineral Safeguarding Areas (Development Plan Documents)

In accordance with Regulations 24(2), 35 and 36 of the Town and Country Planning (Local Development) (England) (Amendment) Regulations 2004 (as amended), Cambridgeshire County Council and Peterborough City Council ("the Councils") adopted on 19 July 2011 the Cambridgeshire and Peterborough Minerals and Waste Core Strategy Development Plan Document and the Cambridgeshire and Peterborough Minerals and Waste Proposals Map C: Mineral Safeguarding Areas.

The details of the document are as follows:-

Title of document:	Cambridgeshire and Peterborough Minerals and Waste Core Strategy Development Plan Document
Subject matter and area:	The document sets out the Councils' strategic vision and objectives for future development and management of minerals and waste within Cambridgeshire and Peterborough, including strategic site allocations, over the Plan period to 2026. The document also contains a suite of development control policies to guide minerals and waste development. The Core Strategy has been subject to a Sustainability Appraisal which can be read alongside the Core Strategy. The document applies to the whole of the administrative areas of Cambridgeshire County Council and Peterborough City Council.
Title of document:	Cambridgeshire and Peterborough Minerals and Waste Plan Proposals Map C Mineral Safeguarding Areas
Subject matter and area:	This document sets out on an Ordinance Survey base Mineral Safeguarding Areas for sand and gravel, brick clay, chalk and limestone within Cambridgeshire and Peterborough. Within the areas identified on Proposal Map C, the Local Planning Authority must consult the Mineral Planning Authority on the types of planning applications specified in Policy CS26 of the Cambridgeshire and Peterborough Minerals and Waste Core Strategy. The document applies to the whole of the administrative areas of Cambridgeshire County Council and Peterborough City Council.

Any person aggrieved by the adoption of Core Strategy DPD and / or Proposals Map C Mineral Safeguarding Areas may make an application under Section 113 of the Planning and Compulsory Purchase Act 2004 to the High Court on the grounds that the document is not within the appropriate powers and / or a procedural requirement has not been complied with. Any such application must be made not later than the end of the period of six weeks starting on the date on which the DPD was adopted.
